<p><b>REFINANCES</b></p>	<p><b>Loan Seasoning for all Refinances (including new construction) require:</b></p> <ul style="list-style-type: none"> <li>• The first monthly payment of the loan being refinanced was made 210 days or more prior to the closing date of the refinancing loans</li> <li>• Minimum of six consecutive monthly payments have been made on the loan being refinanced.</li> <li>• Loans being refinanced within one year from the date of closing, lender must obtain a payment history/ledger from the servicing lender documenting all payments or other sufficient documentation to support the previous two requirements.</li> </ul> <p><b>Streamline refinances (qualifying and non-qualifying):</b></p> <ul style="list-style-type: none"> <li>• Must meet 620 minimum Credit Score.</li> <li>• 0X30 late mortgage payments in the last 12 months or life of loan if less than 12 months.</li> <li>• Single line tri-merge credit report.</li> <li>• Verification of sufficient assets to close if necessary.</li> <li>• Second homes and investment properties are not eligible for streamline refinance.</li> </ul>
<p><b>THIRD PARTY ORIGINATIONS “TPOs”</b></p>	<p>Gateway does not purchase loans originated through TPOs.
